KNOW ALL MEN BY THESE PRESENTS, That The Reorganized Church of Jesus Christ of Latter Day Saints, a corporation incorporated under the laws of the State of Missouri and the State of Iowa in the County of Decatur and State of Iowa in consideration of the sum of One Thousand one hundred sixty four DOLLARS, in hand paid by John Midgarden, W. A. Francis and W. A. Hopkins, Trustees of Rosehill Cemetery and their successors in office authorized by the General Conference of the Reorganized Church of Jesus Christ of Latter Day Saints of Decatur County and State of Iowa do hereby sell and convey unto the said John Midgarden, W. A. Francis and W. A. Hopkins, Trustees of Rosehill Cemetery and their successors the following described premises, situated in the County of Decatur and State of Iowa, to-wit:

Commencing at a point 330 feet East of the Southwest corner of the S.W. 1/4 of the S.E. 1/4 of Section NO-3-67-27, thence North 660 feet, thence West 462 feet, thence North 140 feet, thence East 698 feet, thence South 800 feet thence West 236 feet to place of beginning.
